Hiring Process

All hiring will be on an equal opportunity basis, with preference given to those who can meet the following job related qualifications.

Minimum Requirements Candidates must:

- Possess a high school diploma or GED.
- Have a valid Maine driver's license or the ability to obtained one within 30 days after the employment start date.
- Be 21 years of age or 20 years of age with 60 college credits at the time of application closing.
- Be in good physical condition, pass all phases of the MCJA physical agility test.
- Not have an extensive traffic record, this includes traffic violations or criminal violations punishable by time in jail within the last three (3) years.
- Ability to pass an extensive background investigation including the following checks of workman's comp claims, plus a credit history.
- · Pass the MCJA ALERT test.
- Have the MCJA 100hr Pre-service Law Enforcement Training Program.

The final applicants who are to receive an offer of employment may be required to pass a polygraph, physical, physiological, and drug test to the satisfaction of the Chief of Police.

Applicants already possessing the MCJA full-time certification or can gain waivers through the Maine Criminal Justice Academy are highly desirable. All positions will be filled by an application process with preference given to Fryeburg Reserve Police Officers and individuals with prior certification, training and work related experience in law enforcement.
